REMEMBER, O most gracious Virgin Mary, that never was it known that anyone who fled to your protection, implored your help, or sought your intercession was left unaided. The conversation on Tues Oct. 4 stated that the presented changes were inadequate and would not be approved as a JoF Plan.

Fr. Hastings outlined what he saw as the two acceptable options forward.

When he said 'options'---These are the 'tools' that accomplish "less administrative complexity"---Use one or both of them.

Option 1: Two parishes will cease Sunday/Weekend Mass on July 1, 2023.

Option 2: Adopt a radical reorganization through canonical mergers to streamline administrative complexity.

Option 2 States that Under a Single Parish, Five Churches

One Corporation (One New EIN)

All Bank Accounts live under EIN

There is ONE "General Fund" for Payment of Invoices

- Electricity, Gas, Insurance, Paper Towels, RE Supplies, etc.
- Payment of Pope John Assessment to be paid from General Acct

One Insurance Ledger for All Property Assets

One \$2500 deductible for all property assets for a premium year

One Parish Council and One Finance Committee for the Five

- My vision is that each church campus have 1 or 2 representative(s) on each.
- The group has to be small enough for dialogue and conversation

Option 2 States that Under a Single Parish, Five Churches

Sacramental Records would list
the new parish name
(e.g. Transfiguration Parish)
AND the church name
(e.g. St. Theresa Church)

So a baptism certificate would say "Transfiguration Parish records show that Silvio Schroeder was baptized at St. Theresa Church."
